#### Note of CMU

For students enrolled in the fall semester of 2023:

- 1.According to the regulation of CMU Students' English Proficiency Assessment, Students must pass the minimal English Proficiency Requirement before graduation.
- 2. Taking Physical Education Course is compulsory for first year students (0 credits), students must pass to graduate. For second year or above, Physical Education is elective with 1 credit per semester.
- 3.Defense Education Military Training Course is elective, with 2 hours per week (1 credit).
- 4.General education courses consist of formal courses and general education activities:
- (1)Formal courses: 28 required credits
- i.English (4 credits): A level-based class grouping system is adopted based on students' score of the entrance examination. Students who meet the department's English graduation standard and are approved by the department can be exempted from the course.

- iv.General education courses (21 credits)

#### Note of CMU

For students enrolled in the fall semester of 2023:

- 1. According to the regulation of CMU Students' English Proficiency Assessment, Students must pass the minimal English Proficiency Requirement before graduation.
- 2. Taking Physical Education Course is compulsory for first year students (0 credits), students must pass to graduate. For second year or above, Physical Education is elective with 1 credit per semester.
- 3. Defense Education Military Training Course is elective, with 2 hours per week (1 credit).
- 4.General education courses consist of formal courses and general education activities:
- (1)Formal courses: 28 required credits
- i.English (4 credits): A level-based class grouping system is adopted based on students' score of the entrance examination. Students who meet the department's English graduation standard and are approved by the department can be exempted from the course.

2.For students enrolled in 2023: The study period of the program is five years. The minimum number of credits required for graduation is 167, including 147 required courses credits and 20 elective courses credits (16 credits must be taken from the courses offered in School of Pharmacy).

- \* The hours of pharmacy practice shall meet the following regulation: Compulsory-Pharmacy Internship (I) and (II) should reach 160 hours respectively, with total of 320 hours. Pharmacy Internship (I) and (II) shall complete at least one community pharmacy practice for 2 credits (160 hours); Pharmacy Internship (III) shall complete practice for 640 hours.

- \* The hours of pharmacy practice shall meet the following regulation: Compulsory-Pharmacy Internship (I) and (II) should reach 160 hours respectively, with total of 320 hours.
