藥學系碩士班注意事項

一、教育目標：以中西醫藥之基礎研究與課程學習，培育符合藥學領域之研究人才。

二、114學年度入學新生實施，碩士班修業2-4年，最低畢業學分為33學分，甲組(藥學組)、丙組(藥物開發組)必修14學分(含碩士論文6學分)，選修19學分；乙組(臨床藥學組)必修20學分(含碩士論文 6 學分)，選修13學分，且必須完成「臨床實習(一)」及「臨床實習(二)」者(共計完成36週實習)，始得有「臨床藥學」之註記；各組修課規定：除應修習必修學分外，各組學生需從該組選修課程中，至少擇一門課修習(如該課程有分上、下學期，則皆需修畢，始可認列)，加上其他選修課程後，始可畢業。

三、修業期間除修習本學程規定應修課程外，尚須完成下列校定課程之研修：

(一)「實驗室安全」-校級必修0學分

(二)「研究倫理」-校級必修0 學分。

(三)「分子醫學」-院級必修2學分：

(1)非臨床藥學背景之外籍生可選修國際針灸學程「分子醫學」或國際生物醫學碩士學位學程「分子醫學」。

(2)臨床藥學背景之外籍生可選修「公共衛生學系博士班一年級」之「流行病學」。

四、依據「社團法人臺灣臨床藥學會(105)臨藥字第105051號來函」及本校105.02.16「收發文號1050001699」之簽核記錄辦理：

(一)依『台灣臨床藥學會醫院藥師專業進階制度』規範：一般藥學研究所畢業者跳升P3，執業年資得減免一年；具國內外臨藥所/組碩士或Pharm.D.學位者，跳升P3時，執業年資得減免兩年。查貴校臨床藥學組畢業者，依現有辦法可歸屬「國內臨藥組碩士」折抵執業年資兩年。

(二)學校得於本系「臨床藥學組」畢業學生之成績單備註欄及畢業證書下方，加註「研究領域：臨床藥學」。

五、本學分表做為畢業學分認定之依據。

Note of Graduate Institute of Pharmacy

1.Educational Goals: To cultivate research professionals in the field of pharmacy through foundational research and coursework in both Chinese and Western medicine.

2.Program Duration and Graduation Requirements:Applicable to students admitted in the 2025 academic year (AY114), the study period for the master's program ranges from two to four years. The minimum number of credits required for graduation is 33.

General Pharmacy Group (Group A) and Drug Discovery Group (Group C): 14 required course credits (including 6 credits for the Master's Thesis) and 19 elective credits.

Clinical Pharmacy Group (Group B): 20 required course credits (including 6 credits for the Master's Thesis) and 13 elective credits. Students must also complete Clinical Practice (1) and Clinical Practice (2), totaling 36 weeks of practical training, in order to receive the annotation of "Clinical Pharmacy" on their academic records.

Each student must complete at least one elective course from their designated group. If a course is offered in multiple parts (e.g., Part I and Part II), all parts must be completed for the course to be counted toward graduation.

3.University-Designated Required Courses: In addition to the required courses in the program, students must also complete the following university-mandated courses:

(1) Laboratory Safety – School-level required course, 0 credits

(2) Research Ethics – School-level required course, 0 credits

(3) Molecular Medicine – College-level required course, 2 credits

a. International students without a clinical pharmacy background may take “Molecular Medicine” offered by either the International Master Program in Acupuncture or the International Master's Program of Biomedical Sciences.

b. International students with a clinical pharmacy background may take “Epidemiology” offered in the first-year curriculum of the Ph.D. program in the Department of Public Health.

4.Professional Recognition for Clinical Pharmacy Group Graduates: According to the Taiwan Society of Health-System Pharmacists Official Document No. 105051 and CMU Official Document No. 1050001699:

(1) Under the “Professional Advancement System for Pharmacists” established by the Taiwan Society of Health-System Pharmacists, graduates of general pharmacy programs are eligible for promotion to P3 with one year of practice exempted; those holding a master's or Pharm.D. degree in clinical pharmacy may have two years of practice exempted. Graduates from the Clinical Pharmacy Group at CMU qualify as having a “domestic master's degree in clinical pharmacy” and may have two years of practice waived.

(2) CMU may annotate “Research Field: Clinical Pharmacy” on the transcript and at the bottom of the graduation certificate for students in the Clinical Pharmacy Group.

5.Graduation Certification

This curriculum and credit structure shall serve as the official basis for graduation requirements.
